- 9 - **EVENT:** Rounds 9 and 10 of the Idemitsu Mazda MX-5 Cup Presented By BFGoodrich at Road America are sanctioned by IMSA and held under the IMSA RULES.
- 9.4.6 - **Entries Closing:** Tue., Jun. 7, 2022. Late entries per Art. 4.3.
- 9.4.11 - **Number of Cars admitted**
 A. Practice sessions: 50 Maximum
 B. Qualifying sessions: 50 Maximum
 C. Race: 50 Maximum
- 9.4.13 - **Impound:** Mazda MX-5 Cup Series Trailer in the Paddock per the Technical Department.
- 19 - **Event Logistics:** Exclusively under the direction of and assigned by IMSA. Refer to schedule for Series Paddock load-in times. Team Transporters must not arrive before 8:00 am on Wed., Jun. 29.
- Pre-Staging: Team Transporter pre-staging is permitted Wed., Jun. 29 after 8:00 am. Enter at Gate 6 off State Rd. 67, turn right and proceed to grassy area to the west of the registration building.
- Load-In: Drivers must be at truck and monitoring CB channel 40, no later than 30 minutes prior to load-in start.
- Load-Out: Sun., Jul. 3, transporters must not move until 5:45 pm. All competitors must vacate the Paddock by 11:00 pm Sun., Jul. 3.

- 3.7.2 - **Driver Deadline/Fee:** CoB Tue., Jul. 14. Until CoB Fri., Jul. 24, an expediting fee is charged. No applications (or related documents) processed after CoB Fri., Jul. 24.
- 4.3.6 - **Event Confirmations:** Event Confirmation Declarations must be submitted via MERG no later than 4pm Mon., Jun. 20. \$500 is charged for late Declarations or Driver changes made after this deadline until the close of Sporting Checks. Driver changes after close of Sporting Checks per Art. 11.2.1.A.
- 9.4.14.A - **Fuel Schedule:** The VP depot is located in the center Paddock at the "pit-in" end. VP will deliver fuel to each Team's pit box prior to the Event load-in. To redirect delivery to the Team's garage, please contact VP in advance of the Event.
- A. **Screening Process:** A Covid Roster is no longer required. Participants must electronically complete HIPAA Waiver and COVID-19 Waiver included in the credential application. There is no longer on-site scanning, and stickers for credentials are not required. For Event-specific COVID-19 protocols, please reference the IMSA Event Operations Protocol document.
- B. **IMSA Transporters:** The IMSA Transporters will be accessible. Please enter the doors labeled "in" and "out" appropriately, and follow all instructions listed outside the transporters.  - 13. False Grid:** Parallel to pit lane between the Paddock and pit lane; enter at north end of Paddock from main Paddock road.
 - 14. Pit Lane Equipment:** Hard panels inside the tent and/or flooring are prohibited. The following procedures must be adhered to on pit lane and within the pit lane area:
 - The paved area behind the pit boxes back to the fence must remain a clear fire lane at all times. Heaters of any type prohibited.
 - 15. Spotter Information:** N/A
 - 16. Beacon Location:** Driver's Right, Start/Finish
 - 17. Facility Restrictions:** Pit Lane service lane traffic is one-way, from pit-out toward pit-in. Also, see the track's "General Rules" posted at imsacompetitors.com.
 - 18. Parking Procedure:** IMSA Annual Parking Passes (hang tags) are accepted for Team parking is in designated areas (see map). If needed, limited additional parking passes may be picked up at IMSA Registration.
 - 19. Additional Information:** Additional maps, forms and information specific to this Event at imsacompetitors.com.
 - 20. Track Shipping:** Packages shipped to track may be picked up from Shipping & Receiving (new building adjacent to staging area and west of Registration). If no one available at Shipping & Receiving, go to Administrative Office. A \$5 fee per package is collected at time of pick up.
